

NSYSU Charging Standard for Personal Usage of Sports Venues

1. The Fee-Charging Standards for NSYSU Sports Venues/Facility Usage shall be in accordance with Article 3 of the NSYSU Sports Venue Management Regulations.
2. The sports venues and facilities of the University charge no fee on the usage of physical education courses and sports teams representing the University. Other personal usage by NSYSU students, faculty, staff, local residents, or other individuals shall be admitted through the presentation of the NSYSU Sport Pass or iPass payment per admission. (The sport venues and facilities shall not accept cash payment and shall not offer iPass top-up).

Disability Card holders are entitled to use all venues free of charge. Persons who accompany the disabled are allowed admission at half charge. Spouses or direct relatives of instructors of the university (including contract employees) shall apply for Relative Card before they are entitled to use the venues with employee discounts. When the relative leaves the school, the Relative Card is also void. Those who possess Sports Cards are not required to have a Relative Card. To apply for a Relative Card, bring the employee ID of the relative and government ID of the applicant a one-inch photo, and the application fee of NT\$50 to the management office on the first floor of the gym.

Local residents of the 10 boroughs in South Gushan (Deng-Shan, Feng-Nan, Li-Xing, Xin-Min, Yan-Ping, Wei-Sheng, Hui-An, Shou-Shan, Shao-Chuan-Tou, and Tao-Yuan) and children under the height of 140 cm are entitled to use sports venues at the University at the concession price.

(2) Expiry date: 6 months / 1 year from date of issue

(3) Caution:

- i. The Sport Card shall not be used by anyone other than the original applicant of the pass. The administrative staff retains the right to ask for the presentation of other identification for verification.
- ii. Sports Card holders are to remain in the same status as when the card is issued during the validity period. Once the status is changed, the pass accordingly.

(4) Application procedure:

- i. Online application: Employees or students who hold IC identifications of the University can apply and pay online at http://140.117.147.235/SCMS/scms_login.php
- ii. On-site application: The applicant shall bring valid identification documents and apply and pay at the management office on the first floor of the gym.

(5) Method of refund:

Sports Card holders may apply for refunds within 3 months from the date of issue; the pass and the original receipt of the fee shall be presented to the office when applying for refunds. Those who apply for a refund within 1 month of the issue date can be refunded 80% of the fee. Those who used the pass for over 1 month but wish to apply for a refund within 3 months of the issue date can be refunded 50% of the fee. Those who used the Sports Card for over 3 months shall not be entitled to any application for a refund.
